Geography:

European Union countries (except south Italy to the south of Rome), CIS countries;
In CIS countries not more than 4 000 km from Lithuania's capital Vilnius;
Internal carriages in Lithuania, Latvia, Estonia are also included.
Territory for cabotage carriages – European Union countries.
The liability of the Insurer is according to the Convention on the Contract for the International Carriage of Goods by Road (CMR) (Geneva, 19 May 1956). The compensation shall not, however, exceed 8,33 SDR per kilogram of gross weight.

Sum Insured:

500 000 EUR for each event;
15 000 EUR cargo salvage costs;
500 000 EUR in aggregate per policy.



Deductible:

In case of fire, theft 10% of loss sum, but not less than 1 500 EUR for each event;
1 500 EUR for goods of adjustable temperature, for tobacco;
750 EUR for other events.
